LIABILITY

Non-enrolled students and non-faculty are not covered under the liability and insurance of Ryerson University and therefore you are solely responsible for any injury, damage, loss or theft that may arise from the agreed upon activities.

In consideration of the Board of Governors of Ryerson University allowing my use of Ryerson's facilities as a visitor working on a student project I agree as follows:

1. TO WAIVE ANY AND ALL CLAIMS that I have or may have in the future against the Board of Governors of Ryerson University, and its members, officers, employees, students, agents, volunteers and independent contractors (all of whom are hereinafter collectively referred to as (the Releasees=));

2. TO RELEASE THE RELEASEES from any and all liability for any loss, damage, injury or expense that I may suffer, personal injury due to misuse of equipment (i.e. burns from equipment misuse, loss of limb or digit from equipment misuse or that my next of kin may suffer as a result of my use of Ryerson's facilities as a visitor working on a student project in the course due to any cause whatsoever INCLUDING NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE;
3. TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability for any damage to the property of, or personal injury to, any third party, resulting from use of Ryerson's facilities as a visitor working on a student project; and
4. This agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, assigns and representatives in the event of the death or incapacity.
5. I agree to pay repair or replacement costs for any loss or damage that I might cause to facilities or equipment in the Image Arts Building.

In entering into this Agreement, I am not relying upon any oral or written representations or statements made by the Releasees other than what is set forth in this Agreement.

I HAVE READ AND UNDERSTOOD THIS AGREEMENT AND I AM AWARE THAT BY SIGNING THIS AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS AND ASSIGNS MAY HAVE AGAINST THE RELEASEES.
